I am aware that to make a false statement with regard to my income and claim fees and other concession when the same are not admissible to my son / daughter / ward is an offence for which penal proceedings will be taken against me. If, fail to refund the amount on demand, I agree that Government may receive the same from my property as arrears land revenue.
